#### Guidelines for the video competition

#### "5 (FIVE) reasons why I want to visit my neighbor country"

1. All submitted videos must be in digital video format.
2. Any video submitted by the participant must focus on the neighboring country.
3. All interested participants can work together (in group) or submit their records individually.
4. The length of the video should not exceed 60 seconds (one minute).
5. All uploaded videos, must have a text in document format as an attachment containing the following data:
  - Name and surname of the participant
  - Address, contact e-mail and telephone number.
6. Plagiarism of any kind will result in the disqualification of the proposal.

7. Group video proposals must have a single bearer (Name, Surname, Contact). If the proposal is a selected winner, the person indicated in the submission application will be awarded.
8. There is no fee for participation in this competition.
9. The records can be submitted through the official e-mail address for participation in the competition: 104neighbour@gmail.com, starting on September 28, 2017. Deadline for submission is 17:00, October 20, 2017. The winners will be officially announced on November 10, 2017 at the event which will be organized, but previously will be contacted by phone and e-mail.
10. Materials such as music, pictures, etc. by other authors can not be used for this competition unless the participant/s own the copyright or have permission to use the material for this contest (written form).
11. All citizens of both beneficiaries countries have the right to participate in this competition.
13. The content of the video material must comply with all local and national laws of the country and in accordance with the EU legislation.
14. Content must not: 1) promote unlawful conduct; 2) it must not be able to support or inspire support for racial, religious, sexual or other prejudice; 3) advocate sexual violence or exploitation; 4) to violate the human rights established by law; 5) to violate privacy;
15. The decision of the jury is final. All received videos according to the determined deadline will be evaluated.
17. The organizers of the competition have the right to use submitted videos for future campaigns for the purposes of the cross-border program.
18. The participant is obliged and should keep at least one copy of the submitted video proposal. The competition organizers are not responsible for damaged, lost or not uploaded videos.
19. Organizers reserve the right to cancel, suspend and / or alter this contest, or any part thereof, if any virus, bug, non-authorized human intervention, fraud, technical errors, human error or any other factor Violates the integrity or proper functioning of the competition, as determined by the financier (EU). The financier reserves the right to disqualify any individual who will attempt to act in violation of the rules for participation in this competition.
